

Strava Challenge Competition Terms And Conditions
15 July 2022
Phase 1

1. OMWDC STRAVA CHALLENGE COMPETITION

- 1.1. "Competition" shall mean the **OMWDC Strava Challenge Competition**
- 1.2. "Competition Period" shall mean 00:00 am on Monday, 18 July 2022 to midnight Sunday 7 August 2022;
- 1.3. "Participant" shall mean any entrant into the Competition and any person with whom a Participant may share a prize with this selected team for the **2022 Old Mutual Wealth Double Century race**;
- 1.4. "Promoter" shall mean the personnel, sponsors and appointed personnel working on & with OMWDC under instruction Cape Town Cycle Tour Trust 65 Avenue de Mist, Rondebosch, Cape Town 7701 South Africa
- 1.5. "Prize" shall mean a team entry to the **2022 Old Mutual Wealth Double Century race** as determined randomly by lucky draw by an authorised representative of the Promoter at the conclusion of the Competition Period;
- 1.6. "Winning Entry" shall mean an entry which qualifies to win a Prize in the Competition

2. GENERAL ENTRY CONDITIONS

- 2.1. No late entries will be accepted.
- 2.2. The Competition is open to South African citizens or permanent residents only.
- 2.3. Participants must be over the age of 18 years.
- 2.4. Participants must be in possession of a valid South African Identity Document, a Passport, or driver's license.
- 2.5. Participants must be available on 26 November 2022.

3. THE FOLLOWING PERSONS ARE EXCLUDED FROM THIS COMPETITION AND MAY NOT PARTICIPATE:

- 3.1. a director, member, partner, employee or agent of, or consultant to **Old Mutual Wealth Double Century and Cape Town Cycle Tour Trust**,
- 3.2. a supplier of goods or services in connection with this Competition, including promotional partners, printers, advertising and promotional agencies, professional advisors and staff employed by or contracted to the Promoter/s marketing service providers;
- 3.3. the spouses, life partners, business partners or immediate family members of the people.

4. HOW TO ENTER AND WINNER SELECTION

- 4.1. This Competition will be conducted via Strava on the **Old Mutual Wealth Double Century club/ group** - <https://www.strava.com/clubs/950530/leaderboard>
- 4.2. In order to participate for a Prize, Participants must:
 - 4.2.1. Be an active user on Strava with a public account & be a member of the **Old Mutual Wealth Double Century club/group** with a non-private account so that the participant's info is displayed on the public leaderboard
 - 4.2.2. Must complete all 3 Strava challenges by uploading your cycling rides on to Strava
 - 4.2.2.1. **Challenge 1** :Cycling a total of 200 Km in one week from Monday 18 July - Sunday 24 July
 - 4.2.2.2. **Challenge 2** : Cycling a total of 300 Km in one week from Monday 25 July - Sunday 31 July
 - 4.2.2.3. **Challenge 3**: Complete a single recorded ride of 101km in one day in the week of Monday 01 August - Sunday 07 August

5. IN ORDER TO STAND A CHANCE TO WIN, PARTICIPANTS MUST:

- 5.1. meet all of the stated criteria; and
- 5.2. Qualifying Participants will be included in a list of entrants that will be automatically entered into a lucky draw to determine Prize winners.
- 5.3. Winning Entries shall be determined by means of a 'lucky draw' (by randomiser) which shall take place within 24 hours of the conclusion of the Competition Period.

6. PRIZES

- 6.1. A team entry to 2022 **Old Mutual Wealth Double Century only**. (*Travel, accommodation, gear is not included*)
 - 6.1.1. **Entry requirements and registration for the Old Mutual Wealth Double Century ("OMWDC")**
 - 6.1.2. To compete in the OMWDC, riders must turn at least 18 (eighteen) years in the year of the event.

 - 6.1.4. Riders consent to the use of all photographic or video material pertaining to their participation in the OMWDC made by the organisers or their assignees during any activity deemed to be part of the OMWDC at any time in the present or future.
 - 6.1.5. The organiser reserves the right to refuse any person's entry or cancel any person's entry up to the day before the OMWDC.
- 6.2. The prize winner will be notified via direct messaging on their social media profile within two (2) working days of the Winning Entries having been drawn. The names of Prize Winners shall also be posted on

the **Old Mutual Wealth Double Century & Cape Town Cycle Tour Trust** websites and various of its Social Media Platforms.

- 6.3. **Old Mutual Wealth Double Century & Cape Town Cycle Tour Trust** reserves the right to re-draw for a Prize, and award a Prize to someone else in the event that the Prize winner has not responded to three (3) attempts by **Old Mutual Wealth Double Century & Cape Town Cycle Tour Trust** to communicate with him/her.
- 6.4. No Prize will be awarded unless or until verification of each Winning Entry is made by the Promoter and the Promoter is satisfied, in its absolute discretion, that the criteria for a Winning Entry and the Competition's Terms and Conditions have been met. Should the Participant not qualify to receive a Prize, the Participant acknowledges that he/she shall be required to forfeit it.
- 6.5. In the event that a winning Participant is either uncontactable or in the event that a winning Participant rejects, or declines acceptance of the Prize, the Prize shall be subject to a new draw.
